REQUIREMENTS 申请条件

- Open to citizens of all countries (except Israel) *and fulfill either one of the conditions below:
- Main application must be 50 years old and above, while spouse (if any) has no age limit
- 40 years old and above with investment in real estate specifically for residential purpose with a total amount of at least RM 600,000
- 30 years old and above with children who are pursuing education (below 18 years old) in Sarawak or undergoing long term medical treatment in Sarawak

TERMS & CONDITION

- The S-MM2H programme is for 10 years with mid-term (extension) application on the 5th year. After the end of 10 years, applicant can apply again for another 10 years
- All applications to be submitted to Ministry of Tourism, Arts and Culture
- All applications must be bonded by a sponsor who originated from and currently staying in Sarawak or by a MM2H licensed agent that is registered in Sarawak only.
- All applicants must show proof of financial capability by, either:
 - i. Opening a Fixed Deposit account with local banks in SarawakRM 300,000 for couple; RM 150,000 for individual; OR
 - ii. Presenting the government approved pension funds (for applicant 50 years old and above)RM 10,000 for couple; RM 7,000 for individual; OR
 - iii. Showing proof of monthly off-shore income funds (for applicant 30 years old and above)RM 10,000 for couple; RM 7,000 for individual
 - Applicant to maintain a minimum balance in their Fixed Deposit account throughout the S-MM2H programme:RM 180,000 for couple; RM 90,000
- Applicant and spouse (if any) are required to submit medical report for new application and mid-term (extension) application.
- Applicant is required to submit Letter of Good Conduct from the origin country based on the passport they used for the S-MM2H application.
- All applicants and S-MM2H holders are not allowed to work or be employed by any institutions in Malaysia throughout the programme except where permission has been granted by the Director General of Immigration Malaysia.

- Open to citizens of all countries *(except Israel) 公开给所有国家的公民申请(以色列除外)
- Main applicants must be 50 years old and above 主要申请人必须年满50岁或以上
- 40 years old and above with investment in real estate specifically for residential purpose with total amount of at least RM600,000
 - 40岁或以上的主要申请人,需以居住为目的,投资价值至 少马币60万的住宅房产
- 30 years old and above with children who are pursuing education in Sarawak or undergoing long term medical treatment in Sarawak
 - 30岁或以上的主要申请人,可通过子女在砂求学或自身在砂求医提出申请
